WHAT DOES TRANSGUARD INSURANCE COMPANY OF AMERICA, INC., "TRANSGUARD" **DO WITH YOUR PERSONAL INFORMATION?**

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some
	but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information.
	Please read this notice carefully to understand what we do.

What? can include:

The types of personal information we collect and share depend on the product or service you have with us. This information

- Social Security number, assets and income
- Policy coverage, premium and payment history
- Motor vehicle history, medical history and claims history

How?

If you are a new customer we can begin sharing your information 30 days from the date we sent this notice. When you are no longer our customer, we continue to share your information as described in this notice.

Direct marketing is e-mail, postal mail and telephone marketing. Your telephone and postal mail opt-out choices will last for five years, subject to applicable law. Even if you limit direct marketing, we may still contact you to service your account or as permitted or required by applicable law.

What we do		
How does TRANSGUARD protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. Your information is only viewable to those employees and brokers who need access in order to provide you with our products and services.	
How does TRANSGUARD collect my personal information?	We collect your personal information, for example, when you Apply for insurance, give us your contact or income/asset information Pay your insurance premium by check or credit card or file an insurance claim We also collect your personal information from others, such as state motor vehicle records, insurance brokers, insurance support organizations, affiliates or other companies.	
Why can't I limit all sharing?	Federal law gives you the right to limit only sharing for affiliates' everyday business purposes—information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing.	
What happens when I limit sharing for an account I hold jointly with someone else?	Your choice will apply to everyone on your account unless you tell us otherwise.	

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to
	you.

Other important information

Do Not Call Policy. This notice is the TRANSGUARD Do Not Call Policy under the Telephone Consumer Protection Act. We do not solicit via telephone numbers listed on the state or federal Do Not Call lists, unless the law allows. Our employees receive training on how to document and process telephone marketing choices. Consumers who ask not to receive telephone solicitations from TRANSGUARD and its affiliates will be placed on the TRANSGUARD Do Not Call list and will not be called in any future campaigns, including those of our affiliates. If you communicate with us by telephone, we may monitor or record your call.

We will contact you to tell you what information we have (unless privileged), you may request that we mail you a copy of the information for a fee.
